The Board discussed the Ironton Football situation regarding what they view as poor sportsmanship on the part of Ironton players and staff. They expressed interest in not playing the game next year.

The Board heard input from Chase Kratzenberg, HS Athletic

Director. He was concerned that refusing to play them in a game that is already scheduled would jeopardize South Point OVC membership.

The Board also heard input from Sara Coleman, who said she talked to students about how to handle and react to loss. She used it as a learning experience for the students.

The Board heard input from Mr. Graham, who said he was at Ironton for 15 years and that "winning breeds winning".

Mr. Gue provided the Board with information regarding upcoming changes — after next year South Point will not be playing Ironton in football. Kerr. Mr. Parker made it clear that he does not want to continue to see the students go through the same thing over again. Mr. Gue and Mr. Kratzenburg both thought it best for South Point to go ahead with the one year obligation remaining.

Ms. Arbogast asked about summer and off season conditioning and lifting, and Mr. Graham responded and said the students are working out every day.

The Board wanted to know if the plan for not playing Ironton confirmed.

Ms. Adams reminded those present that South Point Middle School was undefeated before the Ironton game, then after that 75 - 0 loss they lost the rest of the games in the season. She felt it was a blow to their esteem, and that Ironton was not held accountable for the unsportsmanlike conduct. Mr. Parker said he does not want to see SP play Ironton but will back Mr. Gue's decision. Ms. Adams agreed but again reiterated that she would personally prefer that South Point take a stand and not play them any more. Mr. Nuckols said he agrees with that. He hates to see the students go through that any more.

Ms. Arbogast also agreed, but said one more year, then done forever with playing Ironton.

Mr. Gue is to clarify that it includes Middle School and High School both.
